ELIGIBILITY REQUIREMENTS AND SCHOLARSHIP RULES

- Applicant must be a full-time employee of a contracted Pinnacol agency in good standing.
- The contracted Pinnacol agency must have a minimum of \$200,000 in written premium with Pinnacol at the time of application submission.
- The application must be completed and received prior to the CIC and/or CISR class start date.
- Scholarships are awarded for the class registration fee only. The applicant is responsible for any additional costs associated or incurred with the class.
- Scholarships are nontransferable and cannot be redeemed for cash.
- Scholarship monies will be reimbursed to the recipient only after the documentation of class completion and a passing score have been received by Pinnacol.
- Completion and passing score documentation received by the applicant from the National Alliance must be sent to Pinnacol within 60 days of the applicant's receipt of this document using the mail, fax or email addresses above.
- The applicant must be pursuing his or her designation and not simply fulfilling licensing or update requirements. Ruble and Mega programs are not eligible for scholarship reimbursement.
- Selection of scholarship recipients will be conducted by Pinnacol based on eligibility and application content.
- Multiple scholarships may be awarded to one individual based on the number of classes needed to fulfill the designation requirements.
- Applicants will be notified of their scholarship status within five business days of application submission and receipt by Pinnacol.
- Application information will be used solely for the purpose of awarding Pinnacol scholarships.
- Limited scholarships are available. Pinnacol reserves the right to limit the number of applicants per agency.
